

Part Time ECE Resource Consultant (6 Month Temporary Contract)

Family and Children's Services currently has a temporary contract part time ECE Resource Consultant position, within the Special Services Team. This is a 6 month temporary contract running from May to November 2016.

This position is part of the Preschool Support Program is funded by the Regional Municipality of Waterloo Children's Division and focuses services to children 0-6 years of age. It is designed to promote and achieve the integration of children ages 0-6 with special needs into regulated child care programs. Services include developmental screens and assessments for children with special needs and subsequent referrals to appropriate community supports, if needed. In addition, the incumbent will assist families in obtaining child care fee subsidy, placement in an appropriate licensed child care program (centre-based or home child care) and provide support and resources to both child care staff and parents. The incumbent will demonstrate comprehensive theoretical knowledge of and sensitivity to emotional, psychological and social development in general, with specific expertise in the development of infants and preschoolers.

Qualifications:

- Degree / Diploma in Early Childhood Education, (ECE), Family Studies, Child Studies, or
 equivalent, in conjunction with 2 years experience supporting children and families where the
 child(ren) may have special and or social needs;
- Demonstrated developmental assessment skills normally obtained through completion of an ECE Resource Teacher Certificate, or other relevant experience;
- Proven ability to effectively engage families in order to facilitate participation in activities intended to address protection concerns;
- Demonstrated ability to work collaboratively with colleagues, and community agencies;
- Demonstrated organizational ability;
- Excellent written and oral communication skills;
- Previous experience working within a child protection setting an asset.
