There are 4 temporary full-time positions available for periods ranging from 6 months to 22 months in length. The location of this position is Oshawa.

The successful candidates must be able to perform and will be assigned to the various Residential Services and Child and Youth Services teams.

POSITION SUMMARY:

The incumbent could be responsible for the duties of any the following positions throughout their contract, including meeting all related Ministry standards and regulations:

- Placement Worker- including but not limited to securing the most appropriate placements for children and youth, which meet the child/youth's needs including admission/receiving, foster care and OPI placements and selecting/matching children and youth's unique identities with available resources.
- Resource Worker- including but not limited to supporting foster families to meet the needs of children and youth in care of the Society maintaining the foster care services of the Society to meet the Ministry standards.
- Adoption Worker-including but not limited to securing and supporting adoption placements for children and youth providing adoption services to birth parents and adoptive parents throughout the adoption process.
- Family Support Worker- including but not limited to providing child management and parent education services to family receiving protection services, to achieve the goals of maintaining the child in the family where it is consistent with the child's best interest, protection and safety, and supporting the successful integration of the child from CAS care to the family.
- Kinship Worker- including but not limited to facilitating the successful placement of children with kith and kin.
- Child and Youth Worker- including but not limited to providing services to children and youth in the care of the society, following Ministry standards, formulating plans of care to promote the development and well-being of the child/youth and lead to permanence and/or successful independence.
- Connections Facilitator – including but not limited to coordinating and facilitating all internal conferences for the purposes of admission prevention, repatriation/discharge of children and youth in care, transitioning children and youth out of care and/or developing concrete safety plans for families currently receiving service

And any other duties that may be required as per the job descriptions

MINIMUM QUALIFICATIONS:

A B.S.W. or equivalent. A BA in a Social Science with 6 months full-time direct CAS experience or 2 years related experience working with families and/or children (e.g. court clinics, residential programs, probation). Minimum one year related experience. Proficiency in a second language an asset. A valid driver's license with access to a vehicle required.
