EMERGENCY AFTER HOURS SERVICE WORKER

(Contract - Part-Time)

We are looking for innovative, passionate people with child welfare experience who endorse diversity/anti-oppression and is committed to excellence and "How Can I Help?" consensus building leadership style. This is a unique opportunity for you to help shape Peel CAS's child welfare services strategy and delivery.

ROLE SUMMARY:

Acts as first point of contact between the Society and potential clients for all after hours services. This position also investigates cases that meet eligibility for Emergency services, to determine whether a child is in need of protection. Worker is responsible for screening all calls and, in consultation with the supervisor, will conduct investigations where a child is at imminent risk. All other situations requiring immediate after hours services, such as placement of a child, are also critical to this role. This position requires the ability to maintain a work station at home and maintains and updates a file of all necessary manuals, forms, alerts and other documents pertaining to the Emergency After-Hours Service, as provided by Peel Children's Aid.

REQUIRED KNOWLEDGE & EXPERIENCE:

- Effective assessment, interviewing, relationship building skills.
- Solid knowledge and skills related to the Ontario Risk Assessment Model and child welfare case management.
- Good and timely written communication skills, particularly with respect to formulation of accurate, concise recordings.
- Excellent computer skills.
- Superior telephone manner and verbal communication skills.
- Knowledge of family services and child in care issues.

QUALIFICATIONS:

- BSW or MSW degree from a recognized university
- at least one year of related experience in a child protection role
- A class "G" driver's license and daily access to a vehicle are required



HOURS OF WORK:

- Must be available to work all hours outside of the Standard Office Hours of Mon – Fri from 9 a.m. to 5 p.m.

On-Call Duty = \$10.00 per hour
