

# Flexible Recruitment/Resource/Kin Service Worker

Family and Children's Services is seeking one full-time permanent Flexible Recruitment/Resource/ Kin Service Worker. This position will be with the Recruitment team. While this position is permanent, the blended Recruitment/Resources/Kin Service role is new to the organization and will be reviewed after a one-year period. This position is located in the Kitchener office, however the location may change.

Major responsibilities include the assessment of applicants using the SAFE format/ Kin Service Standards to determine their suitability as kinship care/kin service, foster, and/or adoptive parents; providing orientation and PRIDE training to applicants for foster care, kinship care and adoption; consulting with the team providing service to the child and family, ensuring the selection of the most appropriate home for the child; collaborating with Agency workers to coordinate the successful transfer of approved homes or, when it meets the family's needs, providing ongoing support, skill development, coaching and mentoring; recruiting and training foster/adoptive parent co-facilitators in PRIDE Pre-service training; participating in the development and implementation of community development and recruitment strategies to meet the need for foster and adoptive resources for children in care of the Agency.

### **Qualifications:**

- MSW preferred, BSW or a Bachelor's Degree combined with child protection experience
- -Demonstrated ability to work as a member of a team;
- -Strong assessment skills pertaining to family functioning;
- -Awareness of and experience with the needs of kin families;
- -SAFE and PRIDE training an asset;
- -Solid foundation in Trauma and Attachment Theory, Permanency, OnLac, Anti Oppressive Practice, Signs of Safety Framework;
- -Knowledge of the CFSA and Ministry standards and guidelines;
- -Excellent oral and written communication skills;
- -Experience in adult education/training, group facilitation, and developing community awareness is essential;
- -Child welfare experience an asset.
