## **Child Protection Floater Worker**

Position Summary

These services are delivered to children and families according to regulations and standards under the *Child and Family Services Act*, Ministry standards, and the Society's Policies and Procedures.

## Qualifications

Bachelor of Social Work degree (BSW) or a Four year Honours Bachelor degree (BA); preference given to BSW or MSW candidates; over five (5) years in child welfare with preference given to experience in a variety of child protection departments; **candidates MUST be authorized workers**; proven ability and willingness to work as an integral member of a team; strong assessment skills in order to assess clients' needs, formulate plans of service, and monitor/evaluate progress; proven crisis intervention skills; excellent oral, written communication, observational, and listening skills; demonstrated high degree of professional self-motivation and organizational skills; sound knowledge and understanding of the CFSA, Ministry standards, and guidelines for all child welfare programs and agency policies and procedures; strong time management skills; computer literate; the ability to communicate in French is an asset; a valid driver's license and use of a reliable personal vehicle.
