



### **CARE HOME WORKER – TEMPORARY PART-TIME WEEKEND**

The Agency has three (3) temporary part time weekend CARE Home Worker positions available within the CARE Home Program of the Children and Youth Services Team. These are 6 month contracts. We have available one day shift, one afternoon shift and one overnight awake shift.

CARE Homes offer therapeutic foster care with staff supports for children and youth in care of Family and Children's Services. The worker will encourage, monitor, support and counsel up to four (4) children/youth within CARE homes in the community; work in partnership with a multi-disciplinary/agency team to plan and facilitate skill building and activity based programming; prepare weekly reviews, facilitate and document Plan of Care meetings for each child in the home.

The successful candidates will preferably have experience working with or are comfortable working with victims of human trafficking.

- Experience in a residential setting for children/youth preferred
- Current First Aid and CPR certificate and NVCI training certification preferred
