Position Summary

The Camp Driver will:

- Be available Monday to Friday for overnight camp
- Aid the Senior Camp Coordinator with driving duties to and from camp
- Be available to drive throughout the camp (in case of emergency, to bathrooms, to garbage etc.)
- load and unload goods
- plan travel schedules and routes
- oversee condition of vehicle, to ensure safety prior to travels
- ensure the speed limit is followed at all times, and safety precautions are taken
- Organize and lead a variety of small and large group activities each week.
- Be responsible for the direction, leadership, safety, and well-being of all campers.
- Maintain focus on children's needs so that appropriate programs and services are developed.
- Identify and respond to camper behavioural issues.
- Participate and lead in camp programming when needed.
- Encourage physical, emotional, mental and spiritual growth and wellness of all campers.
- Ensure that the site is kept clean, organized, and free of litter.
- Other duties as related to the Camp Program.

Qualifications

- All successful applicants must be students currently in school and planning on returning to school.
- Applicants must be at least **17** years of age.
- Must hold a valid **G** or **G2** class license. (F Class License is an asset)
- All successful applicants will require Standard First Aid with CPR Level C prior to start date.

- Understanding of the unique dynamics that exist within Aboriginal, Inuit, and Métis cultures.
