Reporting to the Service Director, Parent and Child Capacity Building Branch, the Indigenous Project Lead is responsible for the development of cultural resources, strategies and knowledge keepers to assist the Agency in delivering culturally intelligent services rooted in the culture, beliefs and values of Peel Children's Aid Society and the indigenous population we serve.

The successful candidate will assist our organization in developing the 9 Indigenous commitments.

#### SUMMARY OF DUTIES & RESPONSIBILITIES:

- 1. Develop strategies to enhance identification of Indigenous children, youth and families involved with our Agency
- 2. Develop strategies and protocols to enhance cultural plan for children, youth and families with a focus on community of origin
- 3. Develop strategies to:
  - Reduce the number of Indigenous children in care
  - Reduce the number of legal files involving Indigenous children and families
  - Increase the use of formal customary care agreements
  - Ensure Indigenous representation and involvement at the local Board of Directors
- 4. Establish a protocol to integrate Part X into Indigenous practices
- 5. Develop a training strategy that offers the agency staff and leadership an opportunity to understand the history of Indigenous people in Canada, and provides them with an exposure to the many facets of contemporary Indigenous life
- 6. Develop resources, guiding principles, best practice, reports and publications on cultural safety practices
- 7. Develop strategies for recruitment of Indigenous kinship and foster parents
- 8. Establish an Indigenous consultation table and create a plan for the involvement of elders
- 9. Develop strategies for identification and relationship building with local indigenous bands and organizations

#### JOB SPECIFICATIONS/COMPETENCIES:

- Strong knowledge and awareness of Indigenous culture and history, with particular emphasis on child welfare, intergenerational trauma, how to engage effectively with First Nations, Inuit and Métis communities and reconciliation
- Knowledge and experience working with urban Indigenous children, youth and families in a healing and reconciliation capacity
