### **Position Summary**

The Registered Early Childhood Educator is responsible for:

- Incorporating culture, language and traditional practices in every aspect of service delivery
- Outreaching to the community and other programs to recruit families, advertise and promote programs.
- Engaging social media outlets to keep families engaged and briefed on EarlyOn services and communications.
- Completing registration packages with families and keeping updated.
- Planning and developing curriculum focusing on adult education.
- Developing plans, and developing and facilitating programs that support parent/caregiver education i.e., health and wellness, breastfeeding, pre/post-natal education, parenting programs, community resources and development, attachment building, infant mental health.
- Modeling appropriate behaviours to parents/caregivers around health and safety practices, parenting techniques.
- Making referrals to internal and external resources to support families.
- Maintaining communication with internal/external services regarding families' on-going needs.
- Screening every child using ASQ/ASQ SE standards.
- Implementing developmental plans for children based on ASQ/ASQ-SE.
- Developing curriculum for children 0-6 years old with a holistic approach that focuses on creativity and exploration, play, language development, infant mental health awareness, health and safety practices, culture, language and traditional practices.
- Engaging parents/caregivers and children in all aspects of program development and implementation.
- Developing on the land activities for children 0-6yrs.
- Supporting various learning styles and planning accordingly for all children.
- Ongoing support for families in need.
- Ongoing collaborations with community agency/services to support families- building relationships with Toronto Public Health nurses/dietitians, school board representatives, community agencies.
- Developing resources based on child development practices, health and safety practices, referrals.
- Sharing best practices and standardized materials with families.
- Coordinating service meetings in support of families.

- Supporting all ages within the family from prenatal care, middle years, youth, adult and senior programming.
- Providing cultural resources, language and traditional practices and access to Elders and Traditional Knowledge Keepers.
