# QUALITY ASSURANCE WORKER PERMANENT FULL-TIME

Under the supervision of the Quality Assurance Supervisor, the Quality Assurance Worker will work to improve initiatives including program development, system improvement, outcome evaluation, funding submissions, service audits, and training. The Quality Assurance Worker will conduct research, perform analysis within their employment requirements and shall follow regulations, policies and procedures and the mission, beliefs and vision of the Niijaansinaanik Child Well Being Agency. They will contribute to the accomplishment and strategic priorities of the Agency.

#### **KEY JOB FUNCTIONS**

- Consult with programs and services found within the Agency regarding informational needs.
- Develop and refine relevant computer reports and databases.
- Support evidence informed practice integration in Agency functions.
- Liaise with a broad variety of community resources and participate on various committees to identify/share relevant information and promote child welfare services.
- Participate in a Research Review Process which includes the vetting and analysis of submissions and research within established parameters to be presented to the Ethics Committee.
- Work with partnerships and participate with academic, professional, and government institutions to promote child welfare through joint ventures in research, program evaluation, and publication of relevant findings.
- Provide analysis and interpretation of relevant statistics and data to annual and long term planning efforts.
- Provide support in the planning processes, provide consultation on strategies and techniques, and provide support for the Agency's Strategic Planning process and implementation.
- Support integration of Quality Assurance (QA) and Quality Improvement (QI) initiatives within the Agency and develop and maintain expertise to undertake projects (e.g. accreditation, outcome evaluation, client feedback, system and program improvement, consultation).

#### Minimum Education & Experience

- University degree in social services, business/commerce, or equivalent.
- Minimum two (2) years of service and management experience preferably in the child welfare environment or a First Nation Social Service agency

- Knowledge of Niijaansinaanik Child and Family Services programs and services
- Respect for, sensitivity towards as well as knowledge and understanding of Anishnawbek culture, traditions and the Seven Grandfather Teachings
- Basic knowledge of the Child, Youth and Family Services Act
- Knowledge of First Nation service delivery, customs and traditions in responding to child welfare
- · Knowledge of traditional practices, ceremonies and teachings
