## About the Role

We are seeking two (2) **Child Protection Workers** to provide direct intervention and other practical and concrete services to clients using appropriate techniques and methods of social work practice.

# **Responsibilities:**

- Responsible for the investigation of child protection allegations to families and institutions and service to families that require ongoing services.
- Ensure the protection of children by receiving initial referrals and investigating as per the Child & Family Services Act.
- Provide support and intervention to clients using a range of appropriate methodologies and techniques to best meet client needs.
- Liaise with professional and community staff to provide support services in line with the case management plan.
- Provide ongoing duty to report presentations as part of community outreach and agency liaison activities concerning the client population.
- Complete and maintain up-to-date case notes and recordings while complying with Ministry standards.
- Maintain current knowledge of legislation and government prescribed procedures, regulations, and child protection standards as per the Differential Response Model.
- Regularly provide on-call coverage for immediate response cases.
- Required to participate on the emergency after hours team.
- Perform other duties as assigned.
