About the Role

We are seeking a **Social Worker – Housing** to provide services related to accessing safe and affordable housing and homelessness prevention programs. The successful candidate will provide support and counseling to clients to help them develop life skills, social skills, and other competencies that will enable them to secure and maintain housing, as well as introduce clients to a variety of available affordable housing options.

Responsibilities:

- Provide individual, family, or group housing related counselling to clients using a range of appropriate methodologies and techniques to best meet client needs.
- Develop ongoing referral relationships within relevant community service providers and social services systems.
- Carry a caseload of clients with issues related to, housing and mental health.
- Formulate and develop appropriate housing and intervention plans.
- Acquire and maintain an up to date knowledge of community and government resources and changes which would affect Agency clients in particular related to housing.
- Liaise with other agencies focusing on issues of homelessness.
- Assist clients to gain an understanding of issues involved in gaining and maintaining housing so that they do not become homeless.
- Perform other duties as assigned.

- A degree of fluency in the area of landlord/tenant disputes
- Fluency with housing and utilities assistance programs
