Position Summary

Under the direction of the Supervisor, Bekaadendang, the Mental Health Worker Anti-Human Trafficking will:

- Provide specialized counselling services to community members who have experienced sexual exploitation, including sex trafficking, or are at at risk for experiencing sexual exploitation, including sex trafficking
- Provide safety planning, crisis management and related supports.
- Formulate concrete, holistic therapeutic goals and objectives and provide integrated treatment.
- Liase and consult with internal and external collaterals to create a circle of support.
- Inputting reports and data into database.
- Respond to requests for agency information and case consultations as needed.

What we are looking for:

- Master's Degree in Social Work, Counselling Psychology or a closely related field.
- Alternatively, an equivalent combination of education and experience working with Aboriginal peoples in a related setting may be considered. Lived experience and community connections are assets
- A willingness to obtain and pass a Vulnerable Sector Police Record Check.
- High literacy in Aboriginal culture(s), and a concrete understanding of the unique dynamics that exist within the community.
- Intensive knowledge of sexual exploitation and sex trafficking, and their impact on Indigenous community members
- Understanding of human trafficking, sex work, sex trafficking, choice, coercion, and control, impacts on Aboriginal communities, and other related challenges
- Understanding of harm reduction model.
- Understanding of trauma and trauma response, attachment, and attunement
- Understanding of addictions, cognitive impairments, mental health issues, human trafficking, sex trade, H.I.V. post exposure prophylactics and sexual health as it pertains to street involved youth.
- Knowledge and experience working with LGBTQ2 youth.
- Knowledge of the Child, Youth and Family Services Act.
- Excellent interpersonal, communication, counseling and de-escalation skills.
- Good intake assessment, crisis intervention & management, advocacy and problem solving skills.
- Excellent analytical, time management, organizational skills.
- Strong report writing, communication and computer skills.
- Professionalism, initiative and respect for confidentiality.
- Demonstrated understanding, and commitment to, integrating the Native Child and Family Services of Toronto Mission and values in to practice, service and relationships.
- Demonstrated understanding of workplace Health and Safety practices and understanding of an employee's responsibility under current legislation.
