Position Summary

Reporting to the Senior Manager, Real Estate and Procurement, the Bus Driver is responsible for safely operating the bus according to a set daily schedule and ensuring that the bus is in good operating condition at all times.

Main Responsibilities

- Transport community members (primarily ages 3 -5 and 6-15) in a safe and supportive manner using the Agency bus.
- Keep accurate logs as per Highway Traffic Act and the Agency's policies and procedures to ensure the safety.
- Adhere to the Agency's safety procedures.
- Perform daily safety and maintenance checks and report delays, mechanical problems and accidents.
- Clean the bus as scheduled or required.
- Ensure that the bus is safely and securely stored.
- Maintain order and discipline on the bus and make note of any behavioural or disciplinary problems.
- Work split shifts if required.
- Coordinate vacation schedule with NCFST's busing needs during the school year and summer camps.
- Perform other tasks as required to support operations at our Galloway Road location. (i.e. answering phones)

- Pass a vulnerable Sector police record check.
- WHIMIS and First Aid/CPR training would be an asset.
- Knowledge of highway regulations.
