#### JOB PURPOSE

Niijaansinaanik Child and Family Services serves the six First Nation communities of Moose Cree, Mocreebec, Fort Albany, Kashechewan, Attawapiskat, Peawanuck, the Moose Factory Island Local Services Board and the town of Moosonee if there members are located within the jurisdictions of Nipissing and Parry Sound. In addition to the full range of child welfare services the agency also delivers prevention services.
