Program responsibilities include the monitoring and evaluation of any assigned program to ensure the efficient and effective provision of service in accordance with applicable legislation, regulations, standards and Society policies, procedures and practices.

- Internal engagement Inspires influences and develops individuals and the organization as a whole.
- Planning and organizing Organizes work, sets priorities and determines resource requirements. Effectively sequences activities to achieve goals. Translates strategies into step-by-step plans for

actions.

- Quality orientation Implements a quality focused approach when completing work. Monitors and checks work to meet Ministry of Child and Youth Services' quality standards. Effectively manages teams, projects and budgets to support service excellence and deliver quality outcomes.
