The Project Manager – Youth Mental Health & Addictions is responsible to conduct an analysis and feasibility study to determine the need for tier three youth mental health and addiction services in support of child welfare services including Roundhouses, Treatment Models, and a Service Integration Model for individual North Shore First Nation communities. The Project Manager – Youth Mental Health & Addictions will prepare a final report based on the analysis. The Program Manager - Youth Mental Health & Addictions will consult with the North Shore Tribal Council Communities and work with members of the Agency Senior Management Team.

#### **Qualifications**

- University degree, in a social services, health or administration related field.
- Required two (2) years' experience at a senior level position within the child welfare system with working knowledge of the CYFSA, child welfare data elements, funding framework, and organizational service systems.
